#### **ORDER**

WHEREAS, Teachers' Training B.Ed. College, Netaji Subhash Avenue, Silchar, Cachar, Assam-788005 (B.Ed.) (File No. AS-S/E2/96) was granted recognition for conducting B.Ed. course from time to time with an intake of 80 from the academic session 1997-1998 vide ERC order No. 3445 dated 01.05.1997, followed by revised order dated 30.05.2015 with an annual intake of 80 to 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS,** the ERC in its  $263^{rd}$  Meeting held on  $15^{th} - 16^{th}$  November, 2018 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 26.11.2018 to the institution on the following grounds.

1. Building completion certificate is not submitted.

- 2. Plot No., total land area & total built up area not mentioned in the building plan (small font) and also not approved by Govt. Engineer.
- 3. Faculty list is not approved by Registrar of the concerned affiliating body, which is also not as per NCTE Regulations, 2014 s only 4 faculties are on regular basis and 12 on part-time.
- 2. **AND WHEREAS**, the ERC in its  $267^{th}$  Meeting held on  $10^{th} 11^{th}$  February, 2019 considered the matter along with the reply received on 10.01.2019 in response to Show Cause Notice and decided to issued the  $2^{nd}$  show cause notice u/s 17(1) on 21.02.2019 to the institution on the following grounds:-
  - (i) Building completion certificate in the NCTE prescribed proforma duly approved by Govt. Engineer not submitted.

(ii) Part-time faculties are not accepted as per NCTE Regulations, 2014.

(iii) Blue print of building plan duly approved by Govt. Engineer not submitted.

(iv) Website not maintained and updated.

- 3. **AND WHEREAS**, the ERC in its 278<sup>th</sup> Meeting held on 16<sup>th</sup> 18<sup>th</sup> January, 2020 considered the matter along with the reply received on 03.07.2019 submitted by the institution in response to Show Cause Notice and observed as under:
  - (i) Total built up area mentioned in the building plan as 1553.5 Sq. Mts., which is less than required 2000 Sq. Mts. to run 02 units of B.Ed. Course.

WHEREAS in terms of Section 15(1) of the NCTE Act, Teachers Training College, Plot No.731, Vill-Silchar, PO-Rangirkhari, Tehsil/Taluka/Town/City-Silchar, Dist-Cachar, Assam-788005 has applied for grant of permission for B.Ed. Course (Addl. Intake) online on 24/07/2013 for 2 year duration Under Section 15(1) of the NCTE Act, 1993 and hard copy received by Eastern Regional Committee of on 22/08/2012/08/201313.

- 2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and Videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants permission to Teachers Training College, Plot No.731, Vill-Silchar, PO-Rangirkhari, Tehsil/Taluka/Town/City-Silchar, Dist-Cachar, Assam-788005 for conducting B.Ed. (Addl. Intake) Course of two year duration with an additional annual intake of 20 (Twenty), (existing 80 intake + additional 20 intake), thus making the total annual intake of 100 (One hundred) from the academic session 2016-2017 under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
  - (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Regulation Norms & Procedure) Regulations 2014.
  - (iii) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 4. Further the recognition is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-17.
- 5. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a) Sanctioned programmes along with annual intake in the institution:
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left or joined during the last-quarter:
  - d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i) The affidavit with enclosure submitted along with application.
  - j) The institution shall be free to post additional relevant information, if it so desires.
  - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

#### **ORDER**

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS the institution viz. Teachers' Training College, Netaji Subhash Avenue, Silchar, Cachar, Assam-788005 was granted recognition for conduct of B.Ed. course of one year duration with an annual intake of 80 from the academic session 1997-1998 vide ERC order no. AS-S/E-2/96/3445 dt. 01.05.1997.
- 3. AND WHEREAS, the institution viz. Teachers' Training College, Netaji Subhash Avenue, Silchar, Cachar, Assam-788005 has by affidavit dated 12.05.2015 consented to come under New Regulations 2014 and sought for two basic units in B.Ed. course which require additional facilities.
- 4. **AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to fulfilling following conditions namely,
  - (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional fund, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committee with required documents by October 31, 2015.
  - (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.

- (iii) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- 5. Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition to Teachers' Training College, Netaji Subhash Avenue, Silchar, Cachar, Assam-788005 for conducting B.Ed. Programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfilment of the conditions mentioned herein before 31,10,2015.
- 6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
